## a) Damp in Kitchen

It was noted that further investigations were required to determine whether or not new kitchen cupboards would be required following any damp-proof work. In the meantime, a resident offered to supply dehumidifiers to help prevent drawer items (e.g., tea-towels) becoming damp. Actions:

- Chair to speak to neighbour again to explain that a retaining wall is not required but would like permission to install a French Drain.
- Chair to enquire at the forthcoming Community Board meeting whether funding would be available for any damp-proof work and/or replacement cupboards.
- New kitchen units and worktops may be required should the existing ones become damaged on removal.

Chair reported that the annual fire safety inspection had been completed, some fire extinguishers had been replaced and a certificate had been issued.

### 149/23 Speedwatch

a) **MVAS** 

It was noted that:

- Cllr Gassor has in hand the downloading of information from the new MVAS.
- The old MVAS on Buckingham Road is not working properly. This had been reported to Bucks Council who confirmed that it was working properly.
  - Action: Clerk to report again to Bucks Council.
- The police would not carry speed enforcement checks unless it had information from community Speedwatch sessions. However, it was hoped that the information from the MVAS might encourage the police to carry out enforcement checks.

# 150/23 Street Lighting

It was agreed to seek updates on quotations already received for a new street lighting supplier. Action: Clerk to get the updates.

### 151/23 HS2

It was noted:

- That the cancellation of the northern part of HS2 would probably not reduce the size of the IMD at Steeple Claydon. Chair had asked the question but had not received a response.
- The repairs to the bus shelter had not been made.

Action: Roger Behagg to ask for an update on the IMD and enquire when the bus shelter work would be carried out at the next CALM meeting.
